- ☐ If you have a pet we require the vet statement on your Vet letterhead that includes the breed, weight and certification that vaccines are up to date. There is a \$300 non refundable pet fee (per pet) that is due before move in. Prior to move in you will be required to show proof of pet liability insurance. There are breed restrictions and weight restrictions on our rental homes.
